## IMPORTANT INFORMATION

If an old device is replaced with a new one during the term of the insurance, the new device will automatically be covered.
- ✓ All Mobile Insurance is valid for one year. Unless canceled, the policy shall thereafter automatically be renewed for one month each month.
- ✓ The insurer is Allianz Global Assistance – AWP P&C S.A., Saint-Ouen (Paris), Wallisellen branch (Switzerland).
- ✓ Insurance cover is provided regardless of whether the devices were paid for with the card.

The Issuer is compensated by the insurer for resulting personnel, technical (e.g. IT infrastructure) and any other expenses associated with the brokerage and processing of insurance cover. The compensation is in line with the usual market remuneration for the services provided. I acknowledge the Issuer's entitlement to this remuneration paid by the insurer.
- ✓ By signing the insurance agreement, I take out All Mobile Insurance in accordance with the Terms and Conditions of Insurance and the insurance agreement.
